1. ELIGIBILITY:

3. GENERAL RULES:

3-a BASIS OF PREMIUM -

The basis of premium is the unit of exposure used to determine the premium. The symbol indicating the basis of premium is shown on the rate pages with the Classification and Code Number.

The following Symbols appear on the classification and rate pages. These symbols indicate the basis of premium used to calculate the premium.

OL&T M&C SKL

Symbol Basis of Premium

AC Acre means total number of acres.

A Area means the square footage of floor space for entire building, excluding the following:
Basements (unless open to the public)
Mezzanine floor openings
Private residences (charge as apartment)
Areas used by concessionaire's, subtenant's or tenant's if areas are physically separated.
Portions of floors on which 50% or more of the area is used for:
a) storage in connection with building maintenance
b) machinery & equipment pertaining to the service of the building

Building owners measure building area using square footage outside the outer building walls. Tenants measure building area using square footage of leased space.

Rates apply per 100 square feet of area.

AD Admissions means per 100 of persons admitted to event.

F Frontage means total number of linear feet of property abutting street. Rates apply per linear foot.

FL Flat Charge means the manual charge for that classification.

P Payroll

For an individual or partnership, use the actual payroll (\$20,000 minimum) as the annual payroll for each individual insured or each co-partner.

For a corporation, use the actual payroll (\$20,000 minimum) as the annual payroll for each active executive officer.

In addition to the above, charge for the entire payment by the insured for services of employees, whether paid in money or a substitute for money. Rates apply per \$100 of payroll, with a minimum payroll of \$20,000.

Payroll **INCLUDES** the following:

- a) Commissions and bonuses.
- b) Pay for holidays, vacations or periods of sickness.
- c) Payment by an employer of amounts otherwise required by law to be paid by employees to statutory insurance or pension plans.
- d) Payment to employees on any basis other than time worked.
- e) Payment or allowance for hand or power tools furnished by employees.
- f) The value of board and lodging provided to employees.
- g) The value of store certificates, merchandise, credits or any other substitute for money received by employees as part of their pay.

Payroll **EXCLUDES** the following:

- a) Tips and gratuities.
- b) Payments by an employer to group insurance or group pension plans for employees, other than those mentioned in (c) above.
- c) The value of special rewards for invention or discovery.
- d) Dismissal or severance payments except for time worked or accrued vacation.

e) Extra pay for overtime.

Overtime means those hours worked for which there is an increase in the rate of pay for work

- (i) in any day or week in excess of the number of hours normally worked,
- (ii) in excess of eight hours in any day or 40 hours in any week, or
- (iii) on Saturdays, Sundays or Holidays.

If the insured's records show the total pay earned for overtime (regular pay plus extra pay) in one combined amount, extra pay is computed as 1/3 of the total overtime pay if time-and-one-half is paid, or 1/2 of the total overtime pay if double time is paid. Exclusion of extra pay for overtime does not apply to payroll assigned to stevedoring operations.

PA	Per Animal	means the total number of animals.
PB	Per Banner	means the total number of banners.
CD	Per Camper Day	means per 100 camper days. One person at camp for one day is one camper day.
PD	Per Day	means the total number of days.
PG	Per Game	means the total number of games.
PK	Per Kennel	means the total number of kennels (per run).
PP	Per Person	means the total number of persons.
R	Receipts	means the gross amount of money charged for goods, products sold or operations performed. The minimum receipts to be used are \$20,000. 1) Rates apply per \$100 for Premises and Operations Classifications. 2) Rates apply per \$1,000 for Products / Completed Operations Classifications.

U or E Units or Each means the total number designated
For dwellings, each means per dwelling.
For motels, each means the number of units available to be
rented.

TC Total Cost means the total cost to the named insured for all work for
the specific project. Multiply rate by each \$100 of total
cost.

TD Passenger Days means per 100 passenger days.

SPECIAL NOTE: Products / Completed Operations are based upon Receipts.

3-b CANCELLATION -

If insurance is cancelled or reduced at the request of the company or the insured, the earned premium shall be computed on a pro-rata basis.

3-c COVERAGES - OTHER PROGRAMS -

It is permissible to attach any filed form offering supplemental coverage not included in this section. The appropriate rates are to be used.

3-d MAXIMUM & MINIMUM CHARGES -

STANDARD MINIMUM PREMIUM -

The standard minimum premium per location is **\$40.00** per year.

Minimum Retained Premium - **\$20.00**.

EXCEPTIONS TO STANDARD MINIMUM PREMIUM -

Dwellings	\$31.25 (minimum premium)
CPL & FCPL	Manual premiums are the minimum premiums

Classification Minimum Premiums are shown under certain classifications. Refer to the starred (*) items in classification pages. Classification minimum premiums are fully earned at inception.

These classification minimum premiums are indicated by
"* Minimum Premium \$20".

NOTE: A Christmas tree lot minimum premium is shown. This SHOULD NOT be pro rated even though the exposure exists for only one month.

NOTE: Apply increased limits factor to all minimum premiums.

NOTE: If a classification minimum premium is the only classification applying to the policy, then use the higher of the standard minimum premium or the classification minimum premium.

NOTE: If a classification minimum premium is the only classification that exists at a separate (secondary) location, then multiply the classification minimum premium by the increased limits factor for the minimum premium at that location.
Do not add a standard minimum premium to the classification minimum premium.

NOTE: Products/Completed Operations minimum premium is **\$50.00**.
Products/Completed Operations Premiums and minimum premiums shall be separately calculated and not combined with Standard Minimum premiums.

MORE THAN ONE CLASSIFICATION APPLYING: -

All applicable classifications shall be charged. The total of all classifications premiums apply toward the minimum premium at that location.

WHEN CPL AND OL&T ARE CHARGED ON THE SAME PREMISES: -

OL&T - When rating an apartment house with one apartment covered by CPL, do not use area of that apartment in the OL&T calculation.

CPL - When CPL charge is made for one unit of a 2-4 family dwelling, multiply the CPL premium by .75 .

3-e TERM INSURANCE -

The policy may be written for a term up to three years. All rates or premiums contained in this section are on an annual basis.

3-f WHOLE DOLLAR PREMIUM -

The premium for each exposure shall be rounded to the nearest whole dollar, separately for each coverage provided by the policy.

A premium involving 50 cents or over shall be rounded to the next higher whole dollar.

4. **RATING:**

Classifications are listed on rate pages in the manual. There are various rate sections as described under eligibility.

RATING PROCEDURE: for each classification

1. Obtain territory number from Territorial Classification.
2. Obtain code, rating basis and base rate, for the appropriate territory, from the rate classification table. Note: products/completed operations rates are shown for each classification and the rating basis is RECEIPTS.
 - ** A) Apply a 7% credit to habitational exposures, (classification code beginning with 01).
 - B) Apply a 7% credit to habitational exposures, (classification code beginning with 02).
- *** NOTE: Temporary Lead Coverage optionally available - See FL-17
3. Obtain Bodily Injury Factor (Note: includes \$5,000 Property Damage) (single limit includes BI & PD).
4. Adjust Bodily Injury factor (add or subtract) for appropriate Property Damage limit (except single limit).
5. Multiply total of combined Bodily Injury and Property Damage Limits factors (or single limits factor) by the base rate to obtain adjusted rate.
6. Multiply adjusted rate by amount of exposure to obtain premium.
7. Apply any deductible. (Note: Deductible does not reduce Minimum Premium.)
8. Round each classification separately and combine premiums for each location.
9. Use the greater of the standard minimum premium or any classification minimum premium at each location. Multiply this minimum by the increased limits factor. (See notes under minimum premium section).
10. The final location premium is the greater of step 8 or step 9.

Certain classifications show "0.00" on the rate tables. When this occurs refer to Special New York City Rates or to separate classification.
